**GUIDELINES FOR FILLING FORM No. 93 (For an Individual being a citizen of India)**

- Form to be filled legibly in BLOCK LETTERS and preferably in **BLACK INK. Form should be filled in English only.**
- Each box, wherever provided, should contain only one character (alphabet /number / punctuation sign) leaving a blank box after each word.
- All applicants (including minor, mentally ill, unsound mind) should affix two recent colour photographs with white backgrounds (size 4.5 cm x 3.5 cm) in the space provided on the form. The photographs should not be stapled or clipped to the form. The clarity of image on PAN card will depend on the quality and clarity of photograph affixed on the form.
- Signature / Left hand thumb impression should be provided **across the photo** affixed on the left side of the form in such a manner that portion of signature/impression is on photo as well as on form. The photograph affixed on right side of the form should be clear and without any mark.
- Signature /Left hand thumb impression of applicant or Representative Assessee should be **within the box** provided on last page of form.
- Thumb impression, if used, should be attested by a Magistrate or a Notary Public or an Oath Commissioner or a Gazetted Officer under official seal and stamp.
- At the time of applying for PAN, the applicant shall submit Proof of Identity (PoI), Proof of Address (PoA) and Proof of Date of birth (PoDoB).
- Providing Identity proof and Address proof of Representative Assessee are mandatory, if applicable.
